Subject: Proposed Speed Limits Amendment Bylaw 2022 – Recommended minor and

technical corrections

### **Purpose**

The purpose of this memorandum is to recommend and seek your approval of a number of minor and technical amendments to the proposed Speed Limits Amendment Bylaw 2022 before it is released for public consultation (currently scheduled for 6 September 2022).

As Chief Executive, you hold delegated authority from the Board (confirmed by resolution at its meeting on 28 June 2021) to approve any minor and technical amendments to the proposed amendment bylaw before it is released for public consultation.

### **Recommended Amendments**

The recommended amendments are set out below. These amendments are considered necessary to correct minor and technical errors in the proposed amendment bylaw that were discovered by the Safe Speeds project team during the preparation for consultation (subsequent to the Board approving the proposed amendment bylaw for consultation). None of the recommended amendments impact the technical review findings endorsed or the Statement of Proposal adopted by the Board. Those remain unchanged.
