PARTIES

City Rail Link Limited (Assignor)

Auckland Transport (Assignee)

BACKGROUND

- A The Assignor has the benefit of contractor warranties and various subcontractor warranties relating the City Rail Link Project (*Project*). These are listed in Schedule 1 (*Warranties*).
- B The Assignee is the end user of the relevant aspect of the Project, and as such the Assignor has agreed to assign its rights and interest in the Warranties to the Assignee.
- C The parties have agreed to enter into this deed to record the assignment of the Warranties to the Assignee.

BY THIS DEED the parties agree as follows:

1 **ASSIGNMENT**

In consideration of the Assignee's covenants in this deed, the Assignor assigns to the Assignee the Assignor's interest in the Warranties to enable the Assignee to enforce such Warranties, and the Assignee accepts the assignment of the Assignor's interest in the Warranties on and from the date of this deed, or the date that the Warranties are issued if such date is after the date of this deed (*Assignment Date*).

2 ASSIGNOR'S WARRANTY AND COVENANT WITH ASSIGNEE

The Assignor covenants with the Assignee that if any of the Warranties are not assignable to the Assignee but are capable of being enforced after the Assignment Date by the Assignor, the Assignor, will hold such Warranties on trust for the Assignee and will from time to time when requested by the Assignee take steps to enforce such Warranties for the benefit of the Assignee.

3 **ASSIGNEE'S COVENANT WITH ASSIGNOR**

If the Assignor is required to take steps to enforce the Warranties for the benefit of the Assignee pursuant to clause 2 of this deed, the Assignee will pay to the Assignor all reasonable costs and expenses which the Assignor incurs in doing so.

4 FURTHER WARRANTIES

To the extent that there is a contractor or subcontractor warranty relating to C2 or C8 of the Project that is capable of being enforced after the Assignment Date but which has not been included in Schedule 1, or to the extent that a Warranty in Schedule 1 is incomplete, the Assignee shall have the right to request that the Assignor provide such warranty (in full) and the terms of this deed shall apply as if that warranty was listed in Schedule 1.

5 **INTERPRETATION**

In this deed references to the *Assignor*, and the *Assignee* include the respective executors, administrators, successors and permitted assigns of each of those parties.

6 **COSTS**

Each party will pay its own costs of, and incidental to, the preparation and completion of this deed.

7 **COUNTERPARTS EXECUTION**

This deed may be executed in two or more counterparts, all of which will together be deemed to constitute one and the same agreement. A party may enter into this deed by signing a counterpart copy and sending it to the other party, including by facsimile or email.
