	NOTE: The reviewer will have advised whether the activity can continue at the conclusion of this review. Unless this review is accompanied with a "Stop Works" order, Auckland Transport HAS NOT shutdown the site.
Dangerous	This site has been deemed as unsafe and requires immediate attention. CoPTTM requires that all works are to immediately cease and the STMS to go about making the site safe (acceptable level or better) before works can resume.
	A Stop Works Order has been issued for this site. This site may resume operations once all issues are resolved and recommencement approval is given.

- Any fees and additional costs incurred are payable to Auckland Transport
