Te horopaki / Background

- 5. AT regularly reviews and updates all AT policies to ensure that they reflect leading practice, address key risk areas in the organisation and align to Auckland Council direction. This includes reviewing and updating the charter, which is an important governance document that:
 - serves as a reminder for the board of the legal framework within which it operates,
 - documents the policies that the board has decided upon to meet its legal and other responsibilities,
 - assists AT's leadership in delivering good governance,
 - allows communication of the board's policies and expectations to management,
 - sets out the functions and responsibilities of the board and of management,

- provides guidance and comfort to stakeholders that the board has implemented robust governance processes; and
- encourages the board to focus on how it can continuously improve its governance processes for the benefit of AT.

Te hononga ki te "Statement of Intent 2023 - 2026"/ Alignment to Statement of Intent 2023 - 2026

6. The updated charter will assist the board to help the organisation deliver on the principles included in the Statement of Intent 2023 – 2026.

Me mōhio koe / What you need to know

- 7. The contents of the charter were reviewed against the:
 - a. Local Government Act. 2002.
 - b. The Auckland Council Governance Manual Section 11, Council Controlled Organisations.
 - c. Governance and *Accountability of Council-Controlled Organisations*, a report prepared by the Controller and Auditor-General / Tumuaki o te Mana Oratake.
 - d. The Four Pillars of Governance Best Practice.
 - e. The AT Code of Conduct.
- 8. The proposed updated and amendments are reflected in the marked-up version of the charter, provided as Attachment 1.
- 9. The key proposed changes are as follows:
 - a. Expanded the introduction to include the statement that AT has the powers, responsibilities, and roles of both a regional council and road controlling authority.
 - b. Included AT's purpose and principles, its functions, delegated activities, climate-change commitment, ambition, and future vision and tied this back to the board by expanding on the opening sentence in the board commitment paragraph by stating that the board understands AT's

- purpose, principles and functions, supports its ambition and future vision and its commitment to Auckland Council's climate change plan.
- c. Expanded the role of the board and responsibilities of the board to clearly define what its role is and expanded its responsibilities to note its commitment to achieve Auckland Council's objectives as specified in the Statement of Intent.
- d. Included the quorum of the board, using the Local Government Act 2002, Schedule 7 (as noted in the Auckland Council Governance Manual) as guidance which states that, if the board consists of an even number of members, a quorum is half of its members, and if a board consists of an odd number of members, a quorum is a majority of members.
- e. Minor formatting updates and corrections for consistency.
